# Training Requirement for CERT Members

Starting from 2017, there must be a minimum of 4 trained first aiders in a CERT. The course should cover basic first aid, as well as CPR & AED. The course should cover the following topics:

CERT First Aider Course (1 day) / Basic First Aid Course (1 day)

4 hours	<ul style="list-style-type: none"><li>• Introduction to first aid.</li><li>• Management of sprains, dislocations, cuts, fractures and burns.</li><li>• Improvised carrying techniques</li></ul>	Basic first aid for CERT
1 hour	<ul style="list-style-type: none"><li>• Revision, theory &amp; practical test</li></ul>	

Any first aid training providers accredited by Singapore Resuscitation and First Aid Council (SRFAC) may conduct the CERT first aider course / basic first aid course with CPR & AED.

Accepted first aid certifications:

- WSQ Perform Workplace First Aid / Occupational First Aid with CPR and AED
- Standard First Aid with CPR and AED /Basic First Aid with CPR and AED
- Equivalent first aid courses that adequately covers the above topics

Non-accepted first aid certifications:

- Basic First Aid with only CPR or AED
- Community Emergency Preparedness Programme
- First Aid orientation / introduction / awareness courses

- 2i WSQ Respond to Fire and Hazmat Emergency (3 days) *[For tier 1 P&FM premises]* **OR**
- 2ii WSQ Respond to Fire Emergency in Buildings (2 days) *[For tier 1 high risk installations & tier 2 premises]* **OR**
- 2iii WSQ Respond to Fire Incident in Workplace (1 day) *[For tier 3 premises]*

## Response Team Members

- 1i WSQ Respond to Fire and Hazmat Emergency (3 days) *[For tier 1 P&FM premises]* **OR**
  - 1ii WSQ Respond to Fire Emergency in Buildings (2 days) *[For tier 1 high risk installations & tier 2 premises]* **OR**
  - 1iii WSQ Respond to Fire Incident in Workplace (1 day) *[For tier 3 premises]*
- (Refer to the National CERT Standard to identify premise tier classification)

## First Aiders (can be same persons as Response Team Members)

- 1 CERT First-aider course (1 day) *[For all premises]*

Fire Safety Managers attending the CERT courses, will be awarded CPD points accordingly.
